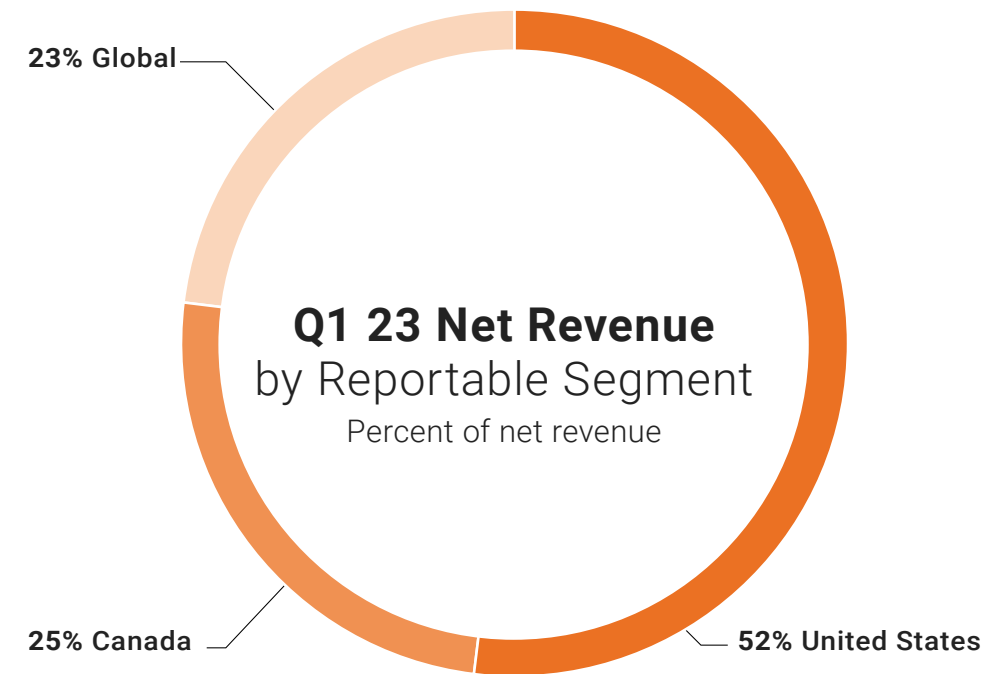

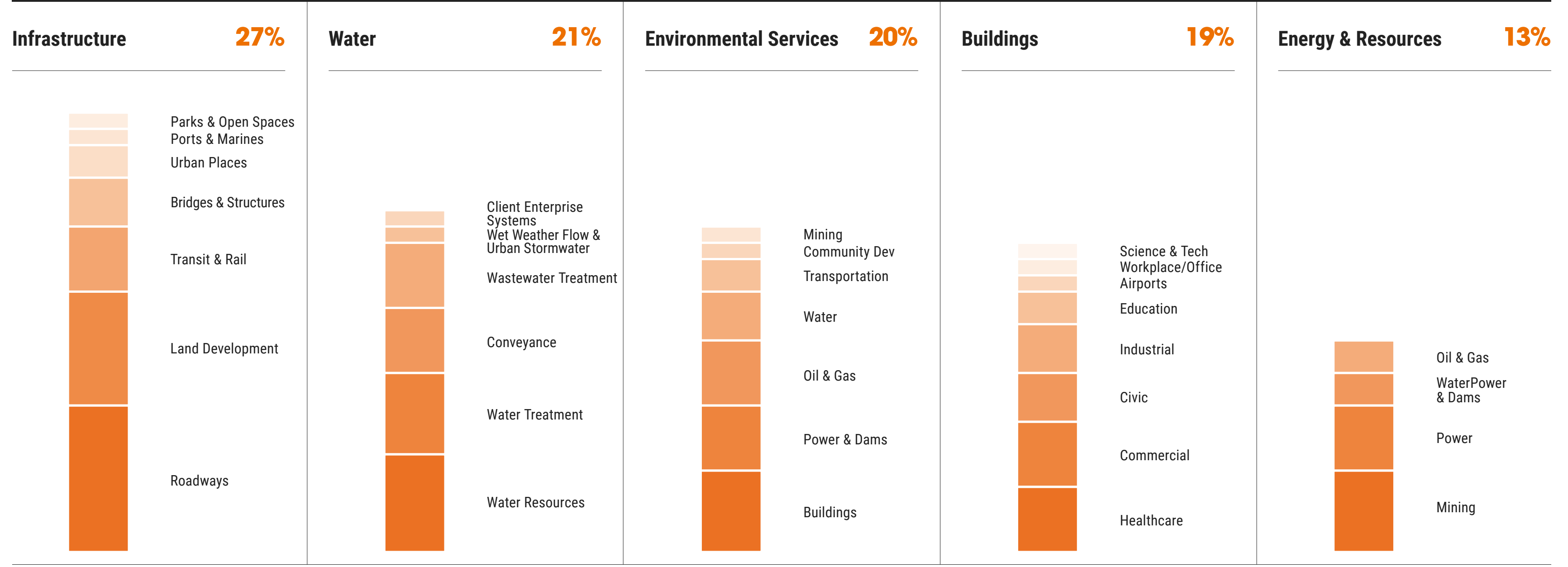
Q1 23 Organic Net Revenue Growth by Reportable Segment

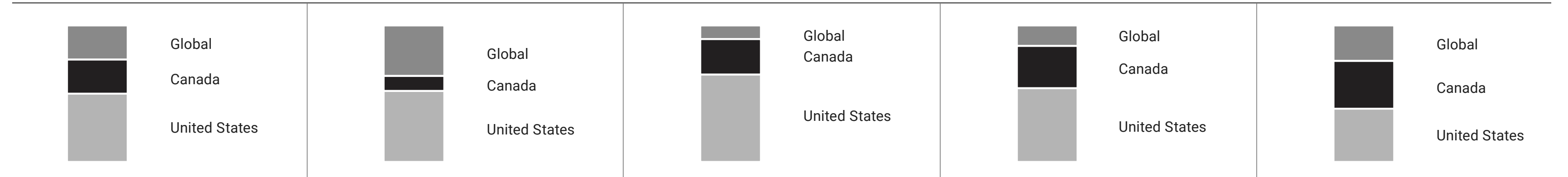

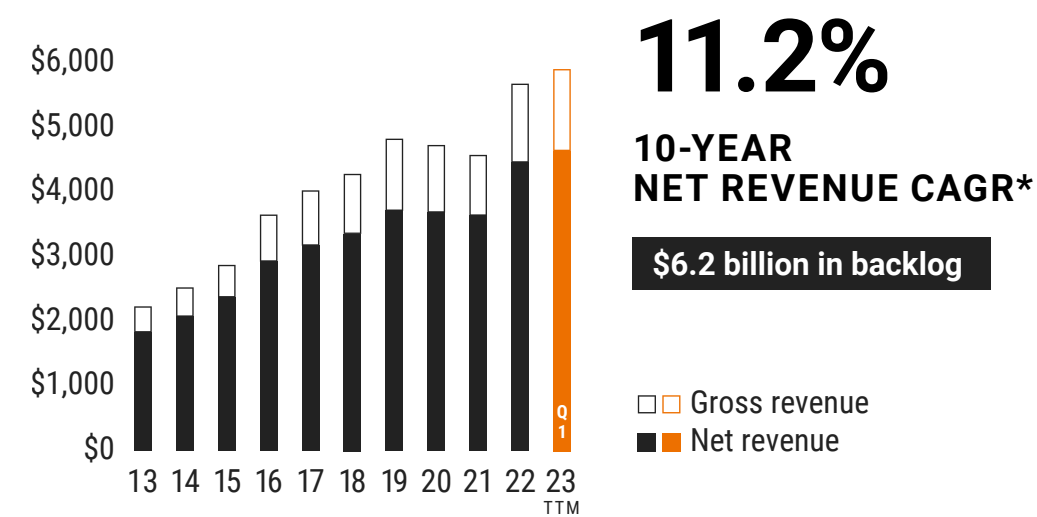

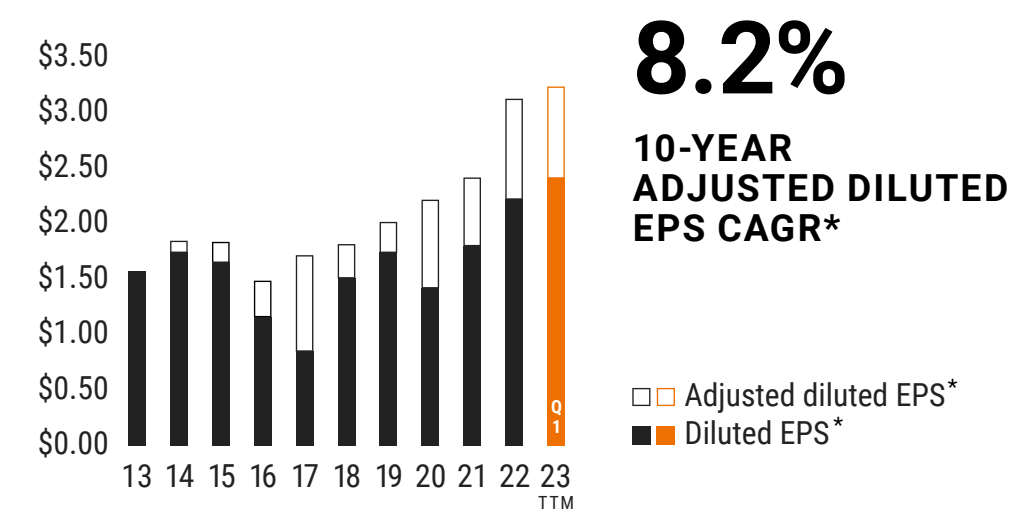

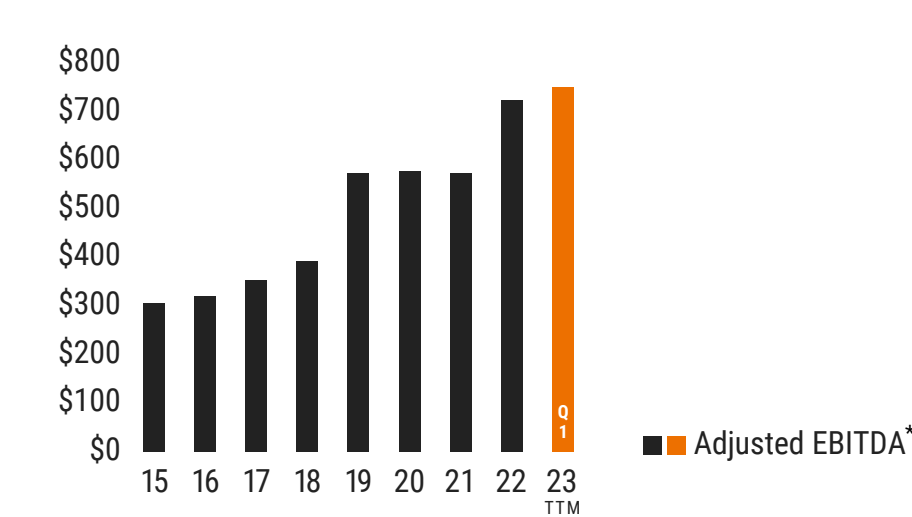
Gross Revenue and Net Revenue millions (C\$)



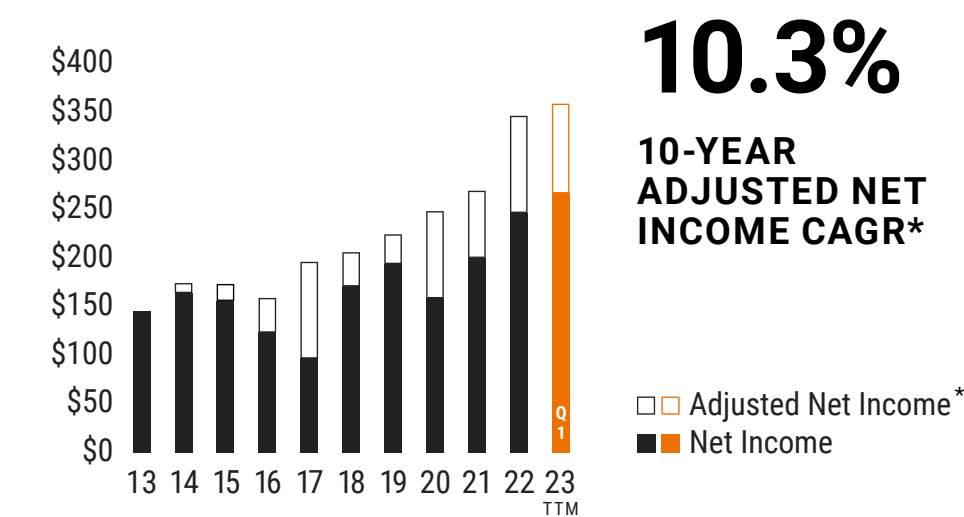
Diluted EPS (C\$)



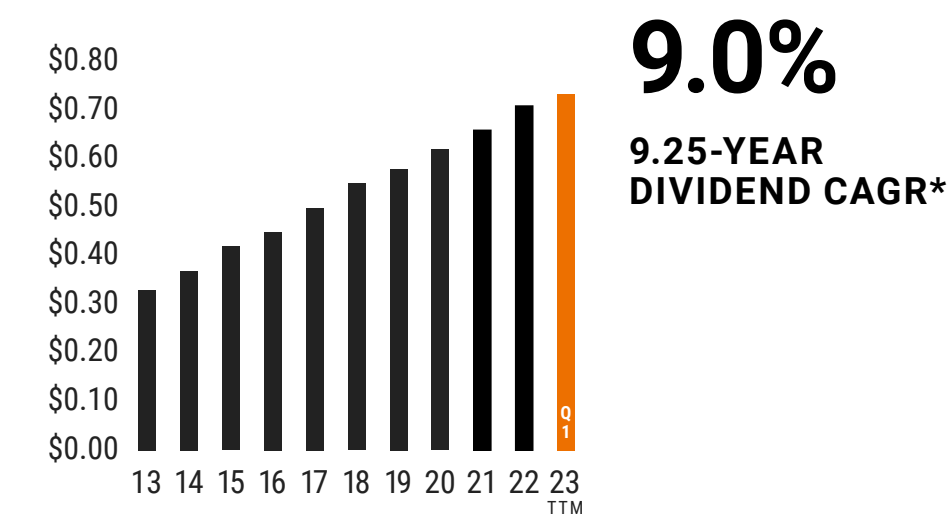
Adjusted EBITDA* millions (C\$)



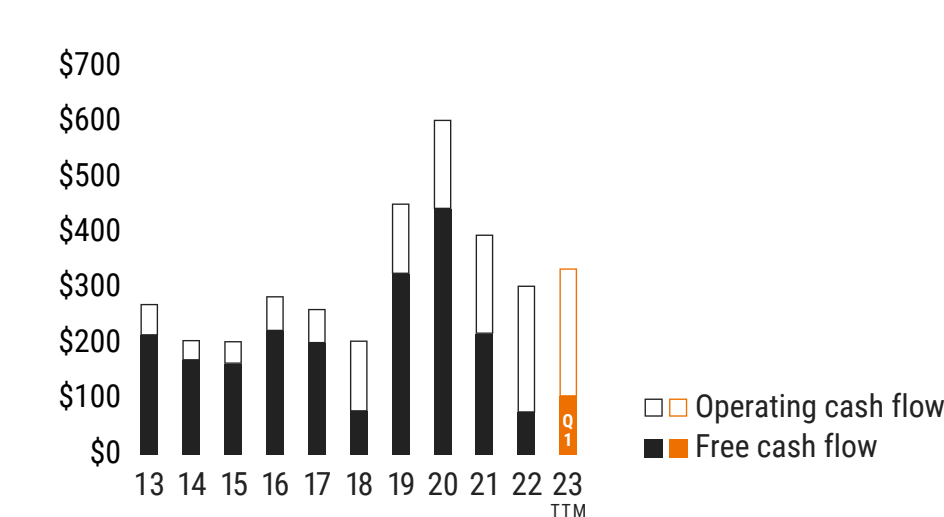
Net Income millions (C\$)
